

Lidget Compton Garden Room Prize Draw Terms and Conditions

1. By entering the prize draw you are agreeing to these prize draw terms and conditions.
2. The prize draw is being run by Lidget Compton Ltd.

Eligibility to enter

3. The prize draw is open to entrants over 18 years of age (Lidget Compton staff members and agents are excluded from the draw).
4. In entering the prize draw, you confirm that you are eligible to do so and eligible to claim any prize you may win.
5. A maximum of one entry per individual is permitted.
6. The prize draw is free to enter.

How to enter

7. The prize draw is open for entries until midnight Monday 2nd September 2024 . Entries after that time and date will not be included in the draw.

The prize

10. The prize will be one Lidget Compton Concrete Garden Room up to the value of £8,000 (based on our August 2024 Garden Room price list).
11. Entrants must have the space at their property to accommodate a building a minimum of 8' wide x 8' long (2.43m x 2.43m).
12. It will be the responsibility of the winner to provide a suitable concrete base for us to install the building on. The concrete base ***is not*** included in the prize. More information on concrete bases can be found in the Help & Resources section of our website.
13. The winner will be drawn at random.
14. The prize is non-exchangeable, non-transferable and no cash alternatives will be offered.

15. The winner reserves the right to contribute towards the building if they want a building valued in excess of the £8,000 prize limit. Please be advised any additional payment would have to be made 14 days prior to the installation of the building.

16. The decision of Lidget Compton regarding any aspect of the prize draw is final and binding and no correspondence will be entered into about it.

Winner announcement

17. The winner will be notified after 2nd September 2024 via the email provided or via our Facebook page.

18. Lidget Compton will attempt to contact the winner by email up to two times.

19. If the winner does not respond to the emails notifying them of their win within 14 days of the second email, they will lose their right to the prize, and Lidget Compton reserves the right to choose and notify a new winner.

Receipt of the prize

20. Installation of the Garden Room will be completed when the first available delivery slot is available. Please be advised during busy periods this could be up to 3 to 4 weeks after the winner is notified.

21. Delivery and installation of the Garden Room will be completed in accordance with our standard terms & conditions which can be found on our website.

Data protection and publicity

22. You consent to any personal information you provide in entering the prize draw being used by Lidget Compton for the purposes of administering the prize draw, and for those purposes as defined within our privacy notice.

24. The winner agrees to the release of their name to any other prize draw participants if requested via Lidget Compton.
